**ORDER GRANTING PARTIES’  
STIPULATED REQUEST FOR  
STAY OF CASE AND SETTING  
ORDER TO SHOW CAUSE RE  
DISMISSAL**

**JS-6: Stayed/Inactive Calendar**

On March 23, 2017, counsel for Los Angeles SMSA Limited Partnership, dba Verizon Wireless (“Verizon”) and the City of Los Angeles (“City”) filed a Notice of a Tentative Settlement of the Case and Stipulation for Request for Stay of the Case (“Stipulation”) in this matter. Having considered the Stipulation, and for good cause shown, it is hereby ORDERED that the Stipulation is **GRANTED**.

Accordingly:

A. This matter is stayed effective as of the date of this Order. Accordingly, the Court places this case on its inactive calendar pending the final resolution of this matter.

1 B. The Court vacates (a) all deadlines set out in the Court's October 24,  
2 2016 Scheduling Order, including the April 3, 2017 deadline for the parties to file any  
3 motions for summary judgment, and (b) all other dates set out in Exhibit A to the  
4 parties' Amended Rule 26(F) Joint Case Management Statement, including the  
5 September 26, 2017 Trial date in this matter.

6 C. An Order to Show Cause re Dismissal is set for September 25, 2017 at  
7 1:30 pm. If a dismissal is filed by September 18, 2017, no appearance will be  
8 required. If a dismissal is not filed, counsel shall file a joint report by September 18,  
9 2017, which shall include the status of the City Office of Zoning Administration's  
10 decision on the redesigned Verizon facility, and whether a revised Scheduling Order  
11 should be issued for the case.
