



## [RVNA Elections 2023](#)

The Reynier Village Neighborhood Association (RVNA) needs you! The RVNA Board is inviting neighbors to become candidates in the upcoming election.

**Our neighborhood association would benefit from our neighbors' fresh ideas and drive to revitalize RVNA and take it to the next level. Whether you would like more community social events, more neighborhood clean-ups, more Town Hall events, new security patrol options, exercise equipment for the park, emergency preparedness training, more interaction with the City Council and South Robertson Neighborhood Council, etc., YOU can make it happen.**

Open seats include:

**Two (2) Co-Presidents:** Either Co-President shall preside at all meetings; shall carry out the intent and purposes of the By-Laws and the duties arising therefrom; shall, when necessary, represent the Association and present positions on behalf of the Association; establish committees to perform duties for the Association; and such other duties as the Association shall from time to time determine. The Co-Presidents shall make parliamentary rulings and shall be ex officio members of all committees:

**Treasurer:** shall collect annual dues and maintain all financial records of the Association; shall be responsible for seeing that all financial obligations of the Association are promptly paid; shall present to the Association a statement of the financial condition of the Association at the annual meetings and at any time upon request of a Co-President of the Association. All checks shall be signed by two of the officers, whose signatures shall be on file with the institution designated by the Association to retain its funds. The checkbook shall be open to inspection by any member in good standing upon reasonable request. The Treasurer shall be required to maintain a current list of paid-up members of the Association and to make such list available to the Co-Presidents and Association at each meeting and at other times upon request.

**Secretary:** shall record and maintain minutes of all meetings and maintain a book of issues and material relating to these issues for reference by the membership. The Secretary shall maintain files and records of the Association.

**Chairperson of Communications:** shall coordinate and direct efforts to communicate with the membership concerning the Association activities and issues which may impact the neighborhood and the greater community. This will be accomplished by individual and committee through the use of (but not limited to) flyers, newsletters, telephone, e-mail, snail mail and the RVNA website. Can work as the webmaster or in conjunction with the webmaster.

**At Large Members:** Explore ideas for activities to benefit Reynier Village residents, help with neighborhood events and any of the above tasks.

**Candidates are to be currently paid members of RVNA (non-members can sign up NOW to qualify). There are no other prerequisites for these positions...just passion for your neighborhood.**
